Restriction REMARK

* Batteries are prohibited,if batteries (DG/NON-DG) are used, defective, damaged and waste. Only brand new batteries are accepted.

*LITHIUM METAL BATTERIES or LITHIUM ION BATTERIES (including power bank) declare as Non-DG are acceptable when it is NOT the single commodity in one container.

DG and NON-DG Lithium batteries all must On deck,away from heat and protected from Sunlight.

*1 9/3090 declared as DG are prohibited only when it is the single commodity in one container.

*2 Class9 un no.3171: used BATTERY-POWERED VEHICLE is prohibited.

*3 Class 4.2 un no.1361 & 1362: irrespective of DG/Non-DG, CARBON/charcoal as a fuel or combustible substances are prohibited.

*4 Class 2.1 & 2.2 UN no. 1950 & 2037 and Class 5.1 UN no. 3377 : prohibited when POD is "MIDDLE-EAST/ RED-SEA/ PAKISTAN" and arriving during Mar.~ Oct.

*5 class 5.1 un no.2014 and class 5.1 un no. 2015 shipping by general dry container is prohibited. WHL will accept UN2014, UN2015 by using tank container only.

B. In REEFER containers:

- DG goods in Reefer container is prohibited except Japan export. (Wan Hai booking only)
- Class 6.1 is PROHIBITED for all ports including Japan export (Wan Hai booking only)
